“Briefing on Hong Kong Authorized Economic Operators (HKAE0) Programme”

The HKAE0 programme is a Customs-to-Business partnership initiative in enhancing the international supply chain security. The HKAE0 qualification represents a ‘Q-Mark’ granted by the Customs and Excise Department (C&ED). As trusted partners of C&ED, HKAE0s enjoy an array of customs facilitation, including less inspection and prioritised clearance for their cargoes both in Hong Kong and customs administrations which have signed Mutual Recognition Arrangement with Hong Kong. This seminar will introduce the HKAE0 programme and its accreditation criteria. An HKAE0 representative will also share its experience on the programme. The seminar will also introduce the Retail Technology Adoption Assistance Scheme for Manpower Demand Management (ReTAAS), which aims at helping the retail industry to adopt relevant information and communications technology and other technologies that help manage manpower demand and enhance productivity.
