The Innovation and Technology Commission launched the Technology Voucher Programme (TVP) in November 2016, aiming to subsidise SMEs in using technological services and solutions to improve productivity, or upgrade or transform their business processes. Each eligible SME may receive a cumulative funding of up to \$200,000. At this seminar, representative of the Innovation and Technology Commission will introduce the details of the TVP, including the eligibility criteria, funding scope, procurement procedures and assessment criteria.
