The Competition Ordinance (Ordinance) has come into force with effect from 14 December 2015. Its enforcement will maintain Hong Kong as a competitive, dynamic and free market by the prohibition of anti-competitive conduct, thereby providing a level-playing field in which consumers, businesses and the overall economy of Hong Kong will benefit. This seminar will explain main provisions of the Ordinance through hypothetical examples.
